


#### History of Legal Development Network



The Network started its formation in 2009 under the name "Community Law Centers Network". Then 8 organizations decided to unite their efforts to develop common approaches for legal support for communities, generalization and standardization of typical applications for legal aid

## Legal empowerment: providing access to justice

#### It has been...

At first the activity of members of the Network focused on the citizens' teaching of their rights and providing the consultations and support of variety of legal issues. It is, above all, client oriented structures where people can get information brochures, consultations, and support with the preparation of documents

#### It is expected...

Providing a legal aid to solve legal issues for at least 100000 persons every year including through online-chat services of the Network's site www.ldn.org.ua

The 1200 residents of communities will obtain a secondary legal aid every year

Development and implementation of redirect system and control of the quality of providing a free secondary legal aid by other providers of the free legal aid

Demonstration at least two distinct advocacy achievements that aimed at improvement the access to justice for Ukrainians

#### It is now...

Providing a primary free legal aid to 40000 persons each year. Also the Network's offices do planned visits to remote regions and villages to advise villagers and share information. Besides, use modern technologies such as, for example, online chat and Skype consultation – for better access to justice. The providing secondary free legal aid is carried out for strategic affairs and redirect to other providers of free legal aid

#### It has been...

The information platform "Legal space" - a tool that the Network uses to improve awareness of the problems and dangers in small and medium sized communities in Ukraine, spreading information about their solutions - through the collection and publication of success stories that gives people hope and faith in the possibility of solving legal issues in a legal way and unites society

#### It is expected...

250 educational events on legal education

5,000 people each year will get knowledge about their rights and how to implement them

1,500,000 people every year will learn about their rights and ways of their implementation and protection.

## Legal empowerment: mechanisms and tools of human influence on the power

#### It has been...

Legal Development Network was created with the aim of Legal Empowerment of the poor people. In connection with the new challenges for the State the Network stopped only providing maintenance services and decided to develop communities which were members of the Network (its offices) as well as to assist other communities seeking development

#### It is expected...

Involving residents to prepare local initiatives

Development of methods of analysis and recommendations on the mechanisms of participation of people in decision-making

Creation and adoption of new mechanisms for people to participate in decision-making

#### It is now...

In terms of decentralization for local government and for most residents of local communities, there was the urgent need to understand the mechanisms and processes of provision of the effective management of local resources. It is equally important for the residents of the community to deal with the issues of access to the mechanisms of democratic participation. The Legal Development Network implements a number of training programs to ensure these needs in the community, particularly schools and local government schools of coaching

### Legal empowerment: mediation

#### It has been...

The direction of this work was generally undeveloped in the Network

#### It is expected...

100 mediations will be carried each year

Training of 30 mediators each year, of which 10 operate in the implementation of mediation in legal disputes

The involvement of judges in six regions of Ukraine

Up to 10 offices of 30 apply mediation in resolving conflicts in offices as inpatient services

Developing the necessary systemic changes for the introduction of mediation in Ukraine

#### It is now...

20 mediators were prepared, more than 10 successful mediations were conducted, cooperation with the judges in the two regions was established, the experience of cooperation on the implementation of mediation in legal disputes was described

To improve quality of legal consulting to veterants of the ATO seeking assistance at state offices of the Network the State legal assistance system, a series of events for training of employees of the state system have been conducted. According to results of events, the Network received a pool of partners in the community who can further provide legal assistance to veterans of the ATO and their families at own communities directly to reduce tensions and resolve conflicts in communities, to accompany typical cases or redirect more complex cases to offices of the Legal Development Network

## Proficient legal support of communities: school resilient services and creating save communities in cooperation with the police and local government

#### It has been...

Mediation as a method of nonviolent conflict resolution began quite actively introduced in Ukrainian schools. Since 2012 the process joined some members of the Legal development Network, conducting painstaking work to promote and implement mediation in partner schools. However, this trend did not become systemic

#### It is now...

The school resilient services are already founded in 16 schools of Kherson, Kharkiv, Vinnytsia and Volhyn regions. They are covering by their activity over 4 thousand children. The implementation of mediation services on the basis of school services, these schools have shown good results. Creating a propaganda teams, conducting of "community values" through the students, the experience of the first mediations and reviews, both parents and the school administration, reduce aggression and conflict among students, improve the atmosphere in schools, mobilizing students to solve conflict independently between peers by nonviolent

#### It is expected...

Prepared 36 own coaches and mediators

Increased qualification of coordinators and personnel services for the implementation of mediation in the community

Prepared 160 children mediators

Created 22 new services in 5 regions, whose activities will cover more than 10 thousand children

School resilient services fulfill primary link of the preventive action to ensure safety in the community

## Community policing: police and community interaction

#### It has been...

From 2015 by support of International Renaissance Foundation the separate offices of the Legal Development Network work in the local communities to identify the needs of citizens in matters of safety and security. First conclusions: the safety in the local communities – is the common responsibility of police, government and citizens, which requires effective cooperation

#### It is expected...

#### Focus at work in the communities

Development of organization and legal capacity of partners through study: how to identify the safety problems in the communities, how to build partnership between communities, government and police, how to find effective forms between them for joint save space

#### It is now...

Conducting joint with the police citizens' receptions, pollings, focus groups, publication of special supplements to newspapers

Organizing of school clubs, coordination offices of safety and common project platforms for local interested parties

#### The strengthening of Roma communities

Roma minority is the most vulnerable and unprotected among the other national minorities that are represented in Ukraine. Majority of romas are not aware of their rights and duties as the citizens of Ukraine, they are not oriented in the legal field, do not know the mechanism of appeal to authorities, socially isolated because of language barrier, illiteracy and poverty

One of the effective mechanisms in solving the problem of Roma communities in Ukraine is providing free legal assistance. Centers of free legal help for romas operate in different regions of Ukraine at support of International Renaissance Foundation. In particular, such centers operate as a part of Legal Development Network (Mukachevo, Svalyava, Cherkasy, Odessa). The Centres are the places where the representatives of roma minorities can get free primary legal help

The main unsolved problems the romas apply to lawyers of legal information and advise are: the inability to obtain basic identification documents, the inability to register the habitation, to receive social benefits, medicaid, education etc. Therefore, the centers not only provide legal assistance on specific issues, but also solve a global problem of strengthening of roma communities

#### The strengthening of Roma communities

#### It has been...

At the beginning of the creation of Legal Development Network the roma community was one of the main direction of its activity. Firstly, this direction was poorly developed

#### It is expected...

Roma NGOs will be capable to represent and protect the rights of Roma in areas of their compact residence. Roma become full members of the community

#### It is now...

After strategic plans elaboration this activity began to grow rapidly. The lawyers of the Network mobile consultations to roma communities, in their compact settlements to provide families with legal assistance, to develop the ability to defend their own rights, to hold law educating events. This gives the opportunity to reduce the violation of roma rights. Work on the development of the Roma communities is carried out in a compact areas inhabited by Roma minorities: in Odessa region, Zakarpattia region, Kharkiv region and Cherkasy region. The achievements in this direction are: reducing the number of people without documents, education among roma minorities, the application of the cooperation of citizens for the needs of Roma with the government through the establishment of working groups in the regional state administrations

By the **program of coaches preparation** conducted the educational events specifically for coaches when they have mastered the theoretical and practical foundations of Coaching. Received knowledge the coaches practically fixed having trained 94 participants of the regional meetings of the Legal Development Network. The Network has received 11 professional coaches who are experts in their field. These coaches are recommended for both internal and external educational events


